I. EFFECTIVE DATE:

Effective as of June 1, 2024 (the "Modification Effective Date") the terms and provisions set forth herein shall amend the terms of the Agreement.


II. **TERM:** The term of the Agreement is hereby renewed for the period of June 1, 2024 through May 31, 2027.

First Amendment to
Agreement To Provide CampusGroups Services
for Old Dominion University

This First Amendment (the "**Amendment**"), effective as of June 1, 2024 (the "**Effective Date**") by and between Novalsys, Inc. ("**Novalsys**") and Old Dominion University ("**Client**") amends the Agreement to Provide CampusGroups Services for Old Dominion University (the "**Agreement**") having a start date of June 3, 2019 by and between Novalsys and Client.

WHEREAS, Novalsys and Client have entered into the Agreement, and both parties wish to amend the Agreement as set forth herein.

NOW, THEREFORE, in consideration of the premises and mutual covenants set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. As of the Effective Date, the applicable Characters and Features and Pricing described in Section C shall be based upon the Revised Quote attached here as Exhibit A.
2. The term of the Agreement shall extend through May 31, 2027
3. Payments shall be made as follows:

June 1, 2024 – May 31, 2025 (12 months): **\$38,890** to be paid by June 30, 2024

June 1, 2025 – May 31, 2026 (12 months): **\$40,017.81** to be paid by June 30, 2025

June 1, 2026 – May 31, 2027 (12 months): **\$41,178.32** to be paid by June 30, 2026

Except as modified in this Amendment, all of the terms and conditions of the Agreement remain unchanged and in full force and effect. In the event of any conflict between the terms and conditions of the Agreement and those in this Amendment, the terms of this Amendment shall govern with respect to the subject matter hereof.

This Amendment may be executed in any number of counterparts and any party hereto may execute any such counterpart, each of which when executed and delivered shall be deemed to be an original and all of which counterparts taken together shall constitute but one and the same instrument.
